DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#103 is a three story brick house approximately three bays square, detached, and with a two story brick "L" shaped wing, five bays long and two bays wide with a two bay square extension and a side balcony. Brickwork is in common bond.

The main entrance occupies the left (W) bay with a paneled door sided by Doric pilasters and a paneled enframingent. This is headed by a flat entablature. The house is approached by a cast iron porch. Front windows are of 1/1 or 2/2 sash and 6/6 sash are used on the wing with wood lintels and sills. On the rear of the front section is a 2/2 JIB window-door with long louvered shutters. This was once protected by an ornate cast iron grill with an acorn oak leaf design, which is now used as a gate to the rear garden. Rear doors contain glass over panels.

The front section roof slopes to the rear and the wing has a shed roof with both being of metal. A bracketed cornice crowns the front facade. A double flue enclosed chimney rises above the east wall.

This building rests on a rather high fieldstone foundation and a one foot square beam runs lengthwise, supported by a round tree trunk section still retaining its original bark. To the rear is a small landscaped garden accented by a tall Magnolia tree and containing brick walks, shrubs and ground covers.
