DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick house detached on the left side, approximately three bays square with an "L" shaped, two story brick wing five bays long and two bays wide with rear balconies, a frame side extension, and frame third story over the wing. All brickwork is of common bond. The front entranceway occupies the night bay with a six paneled door, paneled enframing, narrow transom, and is enclosed by "Tehan style*" Doric pilasters supporting a moulded flat entablature trimmed by modillions and dentils. This is approached by a marble sill and low brick porch with wrought iron railings. A 1/1 sash bay window occupies the second story, left bay trimmed by modillions, carved brackets, fluted pilasters and panels. All other front and rear windows are of 1/1 sash with flat brick arches of shaped voussoirs on the first floor front, regular flat brick arches on the upper stories and wood lintels and sills on the rear area. The front section roof slopes to the rear with the wing having a rather flat shed roof. The front roof cornice is rather simple in design, accented by a band of lozenges and with small fluted and moulded brackets dividing the bays. There is a low foundation.



STATEMENT OF SIGNIFICANCE

*This entranceway was obviously built by John Tehan, the contractor for the nearby Catholic church, who also built or altered most of the houses on this side of the block. They can be identified by pilasters with returns and headed by flat entablatures. This building was probably altered during later Victorian times by the third story addition.
