DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#214 is a 2-1/2 story brick detached house, three bays square with an unusual, one story brick "L" shaped wing, two bays wide and four bays long with an overhanging roof on the entrance side. All brickwork is of common bond recently restored by chemicals and now displaying a light salmon colored brick. A six panel door occupies the right bay with a segmental arched one pane transom. All front windows are now of 1/1 sash with segmental brick arches and those on the second story have louvered shutters, segmentally arched. Rear area windows are of 6/1 sash with wood lintels and sills, and there are four panel doors with two pane overlights. The attic is lighted by a small window in each gable. The front roof section has a moderate slope "A" frame resting on two string brick cornices on the front and rear and small enclosed chimneys rise on each end. The wing has a shed roof and all are of metal. The house sets on a low fieldstone foundation.
