**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#216 is a detached, two story brick house, two bays wide and approximately four in depth with a two story, brick "L" shaped wing one bay wide and three bays in depth with a side balcony. All brickwork is in common bond. The front entrance occupies the right (W) bay with a period door and narrow overlight. Front and side windows are of 1/1 sash and wing windows are of either 1/1 or 6/6 sash, all with two row brick segmental arches, as above the doors. The front section roof slopes to the rear and the wing has a shed roof, both being of metal. The front roofline is decorated by a "V" shaped, Victorian moulded cornice with a band of incised decor and ended by narrow cut brackets. The house sets on a rather high fieldstone foundation.
