#49 is a detached, two story building, probably built of fieldstone, judging by its very thick walls. It is approximately four bays wide and three bays in depth with a full width newer block extension. The older front section is now sealed with stucco. All doors and windows are of newer construction, and a shingled mansard shaped pent roof fronts the second floor, overhanging the first floor. The metal roof slopes to the rear.
