## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached old grain storage building constructed of rather small slabs of native fieldstone. The stone quoins are unusual in that they are not much larger than the wall stones. It is approximately three bays wide and eight bays in depth with a two story full width, brick extension to the rear, three bays in depth.

The center doorway and that on the right (North) side, consist of double doors of diagonal boarding, headed by five pane overlights. These are headed by plain wood lintels. Windows are either single, double, or triple sizes and contain 2/2 sash with wood lintels and sills. Most of these lie in the front or left side facades. Above the front door is a casement window section which may have originally been a Dutch type loading entrance for the second story. The brick extension contains several windows headed by three row header brick segmental arches and the doors are also of diagonal paneling. The front gable is decorated by a scalloped large board trim.
