DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story, old brick carriage house approximately three bays square with the top section hay loft having wood siding. All brickwork is of salmon colored brick laid in common bond. Front and rear walls are centered by wide pairs of board and batten doors retaining several old hinges and headed by long, heavy wood lintels. Above these are smaller hay loft board and batten doors with old hinges and wood lintels and sills. Small windows light the interior and hay loft. The roof has a low slope "A" frame and the gables run front to rear.
