DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Originally, this structure was a Federal double house built in 1812 and known as the Carmack-Harwood house. It was extensively remodeled in mid-Victorian times and now presents one of the most elaborate and unusual Victorian facades in Frederick.

It is six bays long, three bays deep and three stories in height with a flat roof which is stepped down slightly toward the rear of the structure. It is stuccoed brick and painted a soft gray. It is kept in very good condition. The structure reflects Eastlake Gothic style in its trim. The first story facade has a door occupying the third bay from the west and the easternmost bay. The doors are framed in square incised wooden frames with segmental arched tops with a moulded wooden infill above this. The first story windows are 2/2 floor length sashes with wooden frames and segmentally arched tops. The window and door tops on the first floor are flush with a wooden belt-course-cornice which divides the first story visually from the upper stories. It is supported on small brackets which actually are part of the window and door frames.

The second story windows are 2/2 sashes set in Renaissance style frames which protrude out from the wall. They have heavy pediments supported by brackets and heavy frames and sills.

The third floor windows again change in design. They are round-arched, 2/2 windows set in very unusual incised Eastlake Gothic style frames.

It is impossible to ascertain whether these elaborate window frames are carved wood or carved stone or pressed iron.

The top of the building is capped by a heavy moulded and bracketed wooden cornice capped with iron urns.

A very unusual structure with some of the most elaborate window treatments seen in Frederick.
