Tomlinson Inn and Little Meadow are located on the north side of National Pike, three miles east of Grantsville. The Inn sits on the west side of Little Meadow, the valley between Meadow Mountain and Chestnut Ridge. The principal dwelling, constructed circa 1818, is a large, rectangular stone side-gable structure. It has two full stories plus an attic and basement. There are two large gable-end internal stone chimneys rising six courses above the roof-line and capped with semi-circular spark guards. The side-gable roof is covered with asphalt shingles and features cast-iron eagle ice breaks. The main façade has six irregular bays. The windows are six-over-six, double-hung, wood sash windows and casement windows are located at the attic and cellar levels. The doors are twelve-light, wood panel doors. There is evidence of a hip-roofed one-story porch that stretched the full length of the main façade and a three level. Little Meadows is located northeast of Tomlinson Inn. The picturesque mountain meadow is bounded by Chestnut Ridge and Meadow Mountain.

Tomlinson Inn and Little Meadows were listed as a historic district in the ~~1972~~ National Register of Historic Places in 1972. National Register Criteria A, B, and C are applicable for the evaluation of the property's significance in the areas of architecture, military and transportation. Tomlinson Inn is a fine example of a late-eighteenth century hostelry of stone construction. The property is historically significant for its association with the National Road, the nation's first interstate highway, and its association with General Braddock's Fourth Encampment.

Tomlinson Inn and Little Meadow are located on the north side of National Pike, three miles east of Grantsville. The Inn sits on the west side of Little Meadow, the valley between Meadow Mountain and Chestnut Ridge. The principal dwelling, constructed circa 1818, is a large, rectangular stone side-gable structure. It has two full stories plus an attic and basement. There are two large gable-end internal stone chimneys rising six courses above the roof-line and capped with semi-circular spark guards. The side-gable roof is covered with asphalt shingles and features cast-iron eagle ice breaks.

The main façade has six irregular bays. The first story has four six-over-six, double-hung, wood sash windows and two twelve-light, wood panel doors. The second story has five six-over-six, double-hung, wood sash windows. There is evidence of a hip-roofed one-story porch that stretched the full length of the main façade.

The east façade features five six-over-six, double-hung, wood sash windows and four six-light, casement windows. One of the casement windows is situated on the uphill, or south, side at the basement level. The remaining three casement windows are located at the attic level.

The north, or rear, façade has twelve six-over-six, double-hung, wood sash windows; two at each story including the basement level. Each story feature a central door, however the doors on the first and second stories have been sealed. The basement level door matches the doors of the main façade, being a wood panel with twelve lights. Like the main façade, there is evidence of a porch that provided shelter for all three doors. There is a new, poured-cement patio along three-quarters of this façade.

The west façade features seven six-over-six, double-hung, wood sash windows and three six-light, casement windows. One of the casement windows is centrally located at the basement level. The remaining three casement windows are located at the attic level. The first story features a central door, which is now sealed. There is evidence of a porch that provided shelter for this door.

Tomlinson Inn has two large red barns and a garage. The north barn is a cross-gable Three-end Barn with board and batten siding and louvered ventilators. The south barn is a German Bank Barn with two metal ridge ventilators, board and batten siding, louvered ventilators and a Harvestore Silo. The garage has three bays and is clad with board and batten siding.

Little Meadows is located northeast of Tomlinson Inn. The picturesque mountain meadow is bounded by Chestnut Ridge and Meadow Mountain.

Tomlinson Inn and Little Meadows were listed as a historic district in the 1972 National Register of Historic Places in 1972. National Register Criteria A, B, and C are applicable for the evaluation of the property's significance in the areas of architecture, military and transportation. Tomlinson Inn is a fine example of a late-eighteenth century hostelry of stone construction. The property is historically significant for its association with the National Road, the nation's first interstate highway, and its association with General Braddock's Fourth Encampment.

Maryland's land was broken into counties as early as 1637. Each county in Western Maryland was formed from other larger counties as the trans-Allegheny frontier expanded westward. Part of Fredrick County formed Washington County; Washington County gave birth to Allegany County in 1789, but it was not until 1872 that Garrett was named a separate county. The county derived its name from John Work Garrett, a prominent citizen and president of the Baltimore & Ohio Railroad (Tamarack 1968).

Colonel Francis Deakins first surveyed lands in the area that later became Garrett County in 1787. More than four thousand 50-acre lots were reserved for Maryland's Revolutionary War veterans who had served three or more years. Due to the hardships of clearing the virgin forest to create homesteads, few early settlers survived the rugged frontier life. The thin soil covering the region and the short growing season limited agriculture in Garrett County to primarily dairy and livestock. The earliest land grants in this area were issued to John Friend in 1761, Joseph Tomlinson, who named his tract Good Will, and Thomas Bassett who was issued a land grant in 1768 by Lord Baltimore. Two early settlers that endured the difficult setting included Jesse Tomlinson and Thomas Johnson. According to the Military Lots Ledger dated, 1788-1851, these two major landowners dominated the area with their land holdings.

Grantsville is the municipality closest to the Tomlinson Inn/Little Meadows district. The town was named for Daniel Grant of Baltimore who "patented eleven hundred acres just west of the Casselman River . . . under the title Cornucopia in 1785" (Schlosnagle 1978). In 1882, Grantsville was the "largest and wealthiest district in the county, being underlaid with the best coal, and having large tracts of valuable pine and other woods for lumber" (Scharf 1882). Most of the early settlers to the area had established homestead along Braddock's Road by 1785. Population in the area had grown so significantly in numbers by 1817 that Allegany County established Election District No. 3 there. In 1882 mail service was provided for the area at the Post Office established in Jesse Tomlinson's Inn (Schlosnagle 1978).

Agricultural processing industries grew as local farms began yielding surpluses for local, regional, and national markets. Gristmills owned by Jesse Tomlinson and Noah Garlitz of Avilton, provided flour to the region (Tamarack 1968). Coal reserves, vast tracts of timber, and iron ore deposits allowed the residents of Garrett County to exploit the region's vast natural resources.

The emergence of transportation routes contributed to the area's history. Braddock's Road, the route Major General Edward Braddock followed on his way to Fort Duquesne in 1755, was established along the trail taken by George Washington the previous year to Fort Necessity. Later developed for the National Road, the route was established by the U.S. Congress in 1806 as the nation's first interstate highway and "would link the eastern seaboard with the western interior" (Marriott 1995). By the 1920s the National Road became US Highway 40: a chief transcontinental highway

stretching all the way to San Francisco, California. In 1976 the National Road was designated as a National Historic Civil Engineering Landmark.

Travelers have been the county's economic base since the late eighteenth century. The National Road carried people and consumer goods west from such eastern cities as Philadelphia and Baltimore. Traveling in the opposite direction, livestock and other agricultural commodities were transported to eastern markets. Inns, taverns, and drove yards were founded at regular intervals along the corridor. Jesse Tomlinson's Red House Inn, which was replaced by the Stone House, was established near Little Meadow in the 1760s; another inn, the Bear Camp Inn, operated from 1786 to 1817. Local histories and histories of the National Road document the impact of the road to the early mountain communities and they emphasize the importance of the facilities that sprang from it. Many proprietors of these places became indelibly tied to the landscape by having their names attached to the places they settled. Meshach Frost, for example, built Highland Hall near Frostburg in 1812 (Schlosnagle 1978).

Jesse Tomlinson was elected to the state legislature six times before 1815. He kept the Inn himself for only one year after its construction, passing it down to his son-in-law, Jacob Sides. "William Endsley and -----Searight were among the early proprietors of the house. Afterwards William Read, Christopher Hilliard and Truman Fair" all were proprietors. Fair's daughter Rachel played the first piano in the county at the stone house. (Garrett year? Glade Star) Jonathan Huddleston ran the house for six years. Some years later B.T. Garlitz kept the hotel, as did G.L. Layman. Among the notable visitors to Tomlinson Inn is President James Polk. Polk dined at the Tomlinson house in 1845, on his way to his inauguration in Washington. (Searight 1894) During the height of the stagecoach era Tomlinson's Inn served not only as a hostelry and a tavern but also as a post office and polling place.

Little Meadow, the valley adjacent to Tomlinson Inn is historically significant for its association with George Washington and Braddock's Fourth Camp. General Braddock's army camped at Little Meadows June 17, 1755 on their march to Fort Duquesne. The then-Major George Washington was among Braddock's army that camped at Little Meadow. Washington stopped at the meadow many times between 1754 and 1784. (State Roads Commission) Little Meadows remains a sizable tract of uninterrupted, undeveloped mountain meadow.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The Tomlinson Inn is located on the north side of U.S. Route 40 three miles east of Grantsville, Maryland, in the Little Meadows valley.

Huge by Garrett County standards, the Tomlinson Inn's proportions are almost barn-like. The large stone rectangular gable roof structure built on a hillside is three stories plus attic on the down hill side and two stories plus attic on the other. Two large, internal chimneys are located at either gable end; these have very broad stacks being almost one half the width of the end walls. Rising five or six stone courses above the roof, the chimneys are covered with single piece, semi-circular spark guards which look like half of a round pipe. The chimneys are the house's most distinguishing characteristic after its size. The north, or uphill side, has six irregular bays, two of which are doors on the first floor, and five irregularly placed windows on the second story. On the end wall toward the highway, similar six over six windows are located apparently between the flues of the chimney, while the north end wall has a door and windows arranged with what appears to have no relation to the chimney whatsoever. The end walls show evidence of a heavier cornice; while the front of the house definitely did have a porch across it. There was also some attempt made by the original builders to make quoins at the corners.

There are two large red barns and a garage on the property.

To the north of the Inn is the Little Meadows Valley which, today, is a picturesque mountain meadow that has remained largely untouched by civilization.

The boundaries of the Tomlinson Inn and the Little Meadows extend from Chestnut Ridge to Meadow Mountain, in order to preserve the historic character of the Mountain Meadow and environment of the Inn which remains unchanged.

The Tomlinson Inn and the Little Meadows are bounded on the west by the ridge line of Chesnut Ridge, on the east by the ridge of Meadow Mountain, on the north by the northern end of the Little Meadows approximately one-and-one-half miles northeast of U. S. Route 40, and on the south by a line roughly one half mile southwest of U. S. Route 40. The boundaries are specifically defined by the four corners expressed in latitude and longitude.

This National Register nomination is intended to emphasize the inn which can be specifically located in place and in time. The acreage included with the nomination is intended, first, to recognize the existence of a largely unchanged historic environment. Because the environment of the inn included an important eighteenth century military site, which is documented in primary sources but cannot be pinpointed as a building it is felt that the extent of the boundaries is justified. Because of this line of thought the nomination is presented as a building and a building and a site, not a district.

The people of western Maryland consider Braddock's march to Fort Duquesne an extremely important part of their heritage. Recognizing the site of Braddock's Fourth Camp in the Little Meadows on the National Register would be of great local significance.

The historic connection between the Little Meadows and the Tomlinson Inn is governed, as are most considerations in a mountainous region, by geography. The valley between Meadow Mountain and Chesnut Ridge is historically a stopping place on a journey through the Garrett County Allegany Mountains. Braddock's army encamped there and Jesse Tomlinson built two inns. The first one whose site is unknown was replaced by the Tomlinson Inn immediately after the construction of the National Road.

STATEMENT OF SIGNIFICANCE

The Tomlinson Inn was one of the earliest hostelries on the National Road, America's first federally financed highway. The road began in Cumberland and reached the Little Meadows by 1815. Three years later, Jesse Tomlinson built an inn, the Stone House, along the newly opened road. Tomlinson had previously operated a tavern, The Red House, on Braddock's Road located to the north. The tavern on the National Road, operated by tenants, not the Tomlinson family, flourished for several decades. Albert Gallatin who as Secretary of the Treasury had urged the creation of the National Road, stayed there. In 1845, James K. Polk stopped at the Inn on the way to his inauguration. Citizens of near-by Grantsville used the Inn as a social gathering place.

Jesse Tomlinson (1753-1840) who built the Tomlinson Inn was an enterprising frontiersman, accumulating vast land holdings in what is now Garrett County. He represented his region in the Maryland Legislature and served as post-master. He was instrumental in founding Grantsville. Shortly before his death he transferred a twelve hundred acre tract including the Stone House and the Little Meadows to his daughter. The Tomlinson family retained the land until 1867.

The Little Meadows valley has eighteenth century historical associations. General Braddock's army encamped at the Little Meadows, June 17-18, 1755, on the march from Fort Cumberland to Fort Duquesne during the French and Indian War. While at Fort Cumberland, Braddock had sent an advance party to clear a trail (Braddock's Road) through the mountain wilderness to the Little Meadows and to establish a camp site there. Braddock and the army comprised of British and American soldiers including George Washington struggled over the mountains and through dense woods to the Little Meadows, the army's fourth camp after leaving Fort Cumberland. It took ten days to cover the twenty-four miles.

#8 Significance (continued)

At a Council of War held at the Little Meadows, Braddock decided to speed up the army's advance by dividing the army. Approximately twelve thousand troops would proceed allowing the baggage trains and heavy equipment to follow at a slower pace. Although not present at the Council, George Washington had previously suggested such a division to Braddock.

The army continued westward from the Little Meadows to Fort Duquesne where, on July 9, 1775, the outnumbered French and Indian force overwhelmed the English army.

George Washington was familiar with the Little Meadows since he had visited it a year before. In the late spring of 1754 Washington and a party of Virginia militia were on a frontier expedition which included making repairs on the Ohio Company's frontier trail. They spent two days at the Little Meadows mending a bridge. After leaving the Meadows, but while on the same expedition, Washington encountered a numerically superior force of French and Indians who defeated the Virginian's party at Fort Necessity--the incident that started the French and Indian War.

The Ohio Company trail Washington was repairing had been laid out in 1752 by two Maryland frontiersmen, Thomas Cresap and Christopher Gist, and a Delaware Indian, Nemacolin. This trail which Braddock's army followed crossed through the Little Meadows.

In spite of the historical documentation, no known archaeological traces of the Ohio Company trail or Braddock's Fourth Camp exist in the Little Meadows.

Huge by Garrett County standards, the Tomlinson Inn's proportions are almost barn-like. A large stone rectangular gable roof structure built on a hillside, there are 3 storeys plus attic on the downhill side and 2 storeys plus attic on the other. There are two large (internal) chimneys at either end; these have very broad stacks being almost $\frac{1}{2}$ the width of the end walls. Rising five or six stone courses above the roof, these chimneys are covered with single piece, semi-circular spark guards (they look like half of a round pipe). These chimneys are the house's most distinguishing characteristic after its size. The front, or uphill side, has six irregular bays (two of which are doors) on the first floor, and five irregularly placed windows on the second storey. On the end wall toward the highway, there are similar 6/6 windows located apparently between flues of the chimney, while the north end wall has a door and windows arranged with what appears to be no relation to the chimney whatsoever. These end walls show evidence of a heavier cornice; while the front of the house definitely did have a porch across it. There has also been some attempt made by the original builders to make quoins at the corners.

Property has two large red barns and a garage.

Built on the edge of Little Meadows, the Tomlinson Inn was one of the important taverns lining the National Road. Probably built before the 1818 date assigned it [Casselmann Bridge was built in 1813 and these things seem to have been built progressively westward on the National Road - Dr. Schrock], the Inn may be as early as 1813. Built by Jesse Tomlinson [See Stanton's Mill, G-35], a leading figure in Grantsville, the Inn played host to travelers (some undoubtedly important as this was the road to Ohio and the West) and was witness to and a part of the opening of the country in the 'National Period'. Architecturally, the Tomlinson Inn is interesting for its material and size, and its differences when compared to the log and frame structures of the county. Chimney line and general proportions are somewhat Federal, but lacking the refinement of that style.


