DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated in a hilly area off Sam Crow Road approximately 3/8 miles south of the intersection with Green Lantern Road. The house faces northeast. It is a two story, three bay by one bay structure with a gable roof and a gable end facade. The house has a two bay by one bay ell. A single story shed addition runs along the rear, southwest elevation. A porch, supported by plain square wooden posts covers the facade bays. The house can be entered from the central front entrance and from an entrance on the rear addition.

Central glazed brick chimneys are located on the main block and on the ell. The house is lit predominately with one over one sash windows. The windows are framed with plain flat boards. The house rests on a stone foundation with a cellar entrance at the southeast elevation. Asphalt shingles cover the house with tar paper on the roof.


