DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Simon Caton House is located in open hilly terrain. It is a typical western Maryland farmhouse, a frame 2-story, 3 bay by 1 bay dwelling based on the ell-plan.

It rests on a cement block foundation, has asphalt siding (original siding is not detectable) and has a gable roof covered with asphalt.

The facade faces south and has a central entrance.

There is a one-story enclosed shed addition on the east elevation of the ell. Windows are predominately 1/1 sash throughout.

A frame barn lies south of the house.

STATEMENT OF SIGNIFICANCE

This house is an example of a common western Maryland type. Houses of this general configuration, a rectangular main block and rear kitchen wing, were constructed in Garrett County from the late nineteenth through the early twentieth centuries.

According to the present occupant Mrs. Roy Ramhoff, this house was built by Simon Caton approximately 70 years ago for a Showalter, who in turn rented it to Caton. Caton was a coal and clay miner, working predominately at the Benson Mine.

The house originally had 4 rooms; 2 rooms were added on later. The barn was also built at a later time.


