The east-facing facade's center window and flanking doors have been altered. 2/2 windows light the end bays. A shed-roofed porch supported by chamfered posts covers the three central bays. Sliding one-beside-one windows light the half-story.

A rear, shed-roofed ell extends to form a porch. It is supported by a concrete block foundation. Asphalt shingles cover the roof. The building's original German siding is covered in places with asphalt sheets.

A small frame outbuilding stands at the west edge of the rear porch. A frame barn stands south of the house.


