DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Pauline Frazee house is located in the center of a small settlement known as Locust Grove. The settlement is situated in a small valley between four hills in extreme western Garrett County.

The house is a two-story, gable-roofed dwelling with a three-bay, center-door facade. The facade points W. The side elevations of the main block measure one bay wide, and a gable-roofed extension covers the rear elevation. The extension measures two bays on the sides by three bays across the rear.

The house rests on a low stone foundation and is covered with white asbestos shingle over German siding. The windows are one over one sash with simple cornices and plain board surrounds. The roof is covered with standing seam tin.

A one-story, shed roofed porch runs the length of the facade. Its roof is supported by four square posts. A one-story, shed-roofed sunporch spans the width of the rear extension on the S elevation. On the N elevation, the westernmost bay of the rear extension contains a door, sheltered by a small shed porch.

The house has one interior brick stove chimney at the center of the house where the rear extension joins the main block.
