DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Dillon Farm is located on the east side of Cove Road, approximately one-half mile west of US Route 219 south. The farm is on slightly rolling land and includes a house, frame barn, several frame outbuildings and a stone springhouse.

The house is a square-plan, two-story, two-bay by two-bay dwelling with an asymmetrical facade. The facade points west. A one-story, hipped-roofed porch covers the north and west elevations and a one-story storm-porch shelters a door on the north end of the elevation. A one-story, three-sided, hipped-roofed bay projects from the east end of the south elevation on the first floor.

The house rests on a poured concrete foundation which is laid on the coursed stone foundation of a previous dwelling. The walls are covered with white German siding. The windows are one over one sash and have plain board surrounds. The first floor facade, south of center, is a triple window. North of center is the facade door, which has a rectangular transom. The pyramid roof has two-windowed, hipped-roofed dormers on its N, W, & S faces. All roof surfaces are covered with asphalt shingles.

The house has one brick stove chimney on the north face of the roof. The porch roof is supported by square, tapering pillars set on brick pedestals. The interior of the house is unknown.

Southeast of the house is a one-story combination springhouse/washhouse. The N, E, & S walls are constructed of roughly squared and coursed stone, while the west wall or facade is faced in new cement. The gable roof is covered with wood shingles, and the gables are vertical boards. Windows are square nine-light casements covered on the exterior with wooden diagonal lattices and wooden board casement shutters. The entrance, to the south of center on the west elevation, has a board door. North of center on the west elevation is a rebuilt trough which contains the spring water and feeds it to a rebuilt L-shaped trough on the W & N walls of the cooling room. On the E wall of the springhouse is a large exterior fieldstone chimney which serves the washhouse fireplace.

The interior of this building is divided into two rooms: cooling room to the W, washroom to the east. The rooms were originally divided by a board partition, which the current owners have replaced with a stone wall. The floors are stone. The stone-lined fireplace in the washroom has the original lintel, how cracked and mended, and its original iron crane and wash pot. A dutch door in the south wall of the washroom opens to the outside. In the washroom the hand hewn rafters are still visible, while in the cooling room they have been covered with a board ceiling. According to the current owners, this building was originally two stories tall, with a carpentry shop in the frame second floor. This shop burned, and the roof was simply placed on the stone first floor.

STATEMENT OF SIGNIFICANCE

This site is an excellent example of a late 19th through early 20th century farmstead. The house is later than the other farm buildings, which are probably contemporary with a 19th century house which sat on the same spot. The farm has been owned by this family, through the mother's side, since the 19th century.

According to the owners, their mother, Margaret Dillon, collaborated with the carpenter, William Petrie of Salisbury, PA, to produce this house. The house is a well-preserved example of a style of dwelling popular in Garrett County, with its square shape and pyramidal roof with dormers. The owners' father, James Dillon, was a railway mail clerk by profession, but also ran this small farm for the support of his family.

The site also contains a gable-roofed frame bank barn, built 1918 and used as a garage, a frame smoke house later used as a chicken house and now used for storage, a frame pigpen also now used for storage, a kennel, a modern greenhouse, and a frame storage building. The property also contains a large vegetable garden and many flower beds.

According to the owners, at one time the site included, in addition to the extant farm buildings, a coal house, corncrib, and a grist mill, all of which have been demolished.




SPRING
