DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The Fuller-Baker Log House, located one-half mile west of Grantsville, Maryland, sits on the north side of U. S. Route 40, south of the original road bed of the National Road.

The Fuller-Baker Log House is a rectangular log structure of two stories plus attic. It is presently covered with 'insul-brick' and has porch additions the full length of both the south and the north elevations. The 'insul-brick' and porches are to be removed.

Construction is of log planks about eight inches thick; some are 14 and 16 inches broad and a few are 26 feet long. The ends of the logs do not protrude, but are trimmed flush at the corners of the building. The ends of the log planks are notched and laid up "crib" fashion, and the crevices between are chinked with clay plaster and small stones.

A staircase and passageway, partitioned from the middle of the house, are not original to the building as there is structural evidence that there was a great central chimney with fireplaces.

An interior chimney in the east end of the building has an unexplained masonry formation resembling a fireplace but standing only two feet above ground level.

STATEMENT OF SIGNIFICANCE

The Fuller-Baker Log House is an example of a log dwelling once common on the Allegheny-region frontier. The Council of the Alleghenies, Inc., recognizing the architectural and historical importance of this log house, purchased the property in 1968. The Council is restoring the structure in order to illustrate the way of life of the people who first settled in the area.

In addition to the building itself, the site has historical significance of national scope. Just north of the log structure lies the roadbed of the National Road, the first federally financed highway and one of the most important routes westward in the pre-railroad era. National leaders like Andrew Jackson, Henry Clay and James K. Polk traveled the National Road to and from Washington, D. C. The second event of national importance happened a century earlier. In July of 1755 General Edward Braddock's army, which included American soldiers, notably the General's aide, Lt. Colonel George Washington, encamped near the Fuller-Baker Log House en route west to meet the French forces at Fort Dusquene.

Thomas Johnson (1732-1819), the first Governor of the State of Maryland, purchased the lot on which the Fuller-Baker Log House sits. The tract was one of 460 similarly sized, fifty-acre lots in what is now (1970) Garrett and Allegany Counties in Maryland which Johnson purchased at the same time. The State government created these fifty-acre tracts, called the Military Lots, out of vacant land west of Cumberland and gave them to Maryland veterans of the American Revolution--one lot was to go to each private; four lots to each officer. In 1791, after the initial division of the land, the State sold the unclaimed lots. Johnson, taking advantage of the opportunity, bought 23,000 acres within the Military Lots area including the fifty-acre Military Lot No. 2206 on which the Fuller-Baker Log House is situated.

After Governor Johnson's death, Military Lot No. 2206 became the joint property of his son Joshua Johnson and Thomas Hammond. In 1833 and 1842 Johnson and Hammond

patented 169 Military Lots, including No. 2206.

The house bears the name of the nineteenth-century owner, Henry Fuller (1800-1881). He was a stone mason who settled in the area in 1837. Fuller also operated a tavern in nearby Grantsville. The documentary evidence listed herein suggests that Henry Fuller occupied the Fuller-Baker Log House.

Local citizens interested in the history of the area have maintained that, owing to its unusually large size the Fuller-Baker Log House could have served as a tavern.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The Fuller-Baker Log House is a rectangular log structure of 2 storeys plus attic. It is presently covered with 'insul-brick' and has the additions of porch on front and rear (all to be removed). Constructed of very wide white pine and hemlock beams, there is some original chinking remaining. There is a later interior partition (to be removed also) and a later staircase, both of which are where there was probably a large central fireplace, for the attic is blackened above this area, suggesting the burning of such a fireplace. There is also another 'mystery' fireplace in the east wall; there are bricks (forming the back ?) only up to a level of about 2 feet, suggesting perhaps a lower ground floor, a cellar fireplace, or a strangely shaped fireplace.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

Important as one of the taverns on the National Road, the Fuller-Baker Log House is especially important as a fairly well preserved (structurally) log house, associated with the opening of the Ohio Valley and thus with Garrett County. Log houses were built down through the Alleghenies and the southern Appalachians and were characteristic, however, too few of this size and condition remain. Important as a representative example of a type in American architectural history -- the log house (not the log cabin) -- which was employed primarily by German and Scotch-Irish settlers in the late 18th and early 19th centuries.





Fuller-Baker Log House

(Illustrations on front cover by JAN GLEYSTEN)

The Fuller-Baker log house on the old National Road (now U. S. Route 40), purchased by the Council of the Alleghenies in March, 1968, is situated in Shade Hollow one mile west of Grantsville, Maryland. The building is estimated to have been built between 125 and 150 years ago; in fact it may have been constructed soon after the Cumberland Road had reached this point in 1813.

The two-story log house is located in a historic spot, perhaps 100 yards from General Braddock's Fifth Camp, pitched June 19, 1755. At this encampment on his ill-fated expedition to Fort Duquesne (Pittsburgh) he left his heavy artillery and baggage behind and moved up the steep mountainside with his 1200 carefully chosen men and officers.

Adjoining the 11-acre tract to the north are two once-beautiful stone arch bridges, constructed about 1813 by the Cumberland Road Construction crew. One of these bridges crosses Big Shade Run and the second crosses Little Shade Run—both emptying into the Casselman River just south of the log house. These bridges are of considerable historic interest and should be restored to their original state.

It is the intention of the Council of the Alleghenies to restore the house as a monument to a by-gone era and a significant chapter of American life. This structure may well be the first early log dwelling on present Route 40 (The Old National Road) to be preserved and restored to its original state. Since not a single log tavern remains between Cumberland and Wheeling, and only a few stone and brick taverns, the restoration of this fine old edifice in Western Maryland near the historic Braddock Trail (earlier Nemaocolin Indian Trail) is doubly significant.

Historic Frostburg Homes

By JEANNE M. CORDTS

Frostburg, Maryland boasts many historic and charming homes, a few dating from the earliest days of the National Road, some contemporaries of the famed "Southern Mansions," some built in the later 1800's. There are homes that stand straight and unembellished in their original dignity. Others have been almost hopelessly renovated and disguised, unrecognizable except by those with long memories or a fascination for old books and heirloom photographs.

Time and fires have taken their devastating toll of the earliest frame homes in Frostburg. Most of these lay along the National Road which was open as far as Frostburg by 1813. In 1800 there were perhaps three homes. \*By 1823 there were seven houses. In 1812 Meshack Frost (an early landowner for whom the town was later named) laid out lots to sell for \$25, \$40 and \$50. In the next 25 years a great many homes were built, some constructed of the white pine abundant in the forests, some of bricks made in the Frostburg area.


