The Church of God is located on the corner of Bear Hill and Hare Hollow Roads, near Jennings. Immediately to the E is Jennings United Methodist Church.

The Church of God is a one-story, gable-roofed, T-plan structure resting on a low stone foundation. The walls are covered with aluminum siding and the roof with asphalt-shingle. The windows are two-pane sliding windows in metal frames. On the facade (N elevation) an older, one over one sash window remains. The entrance is at the E end of the facade. The church has one central stove chimney.

The church has had several additions and has been so altered that it lacks architectural significance.


