DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This log constructed house is situated in a hilly area approximately 1/2 mile off Route 40 and approximately 1/8 mile east of Route 219. The main part of this log constructed house is a two story, two bay by one bay gable roof structure, gable end front, with the roof sloping down to a story-and-a-half one bay by three bay section. A single story one bay square shed addition is located to the south end of the rear east elevation. The house can be entered from the south elevation of the main block and of the rear shed addition.

The house has a central brick chimney. Two over two sash windows light the house. The house rests on a cut sandstone foundation. Tar paper covers the two story section with tongue and groove vertical siding on the rest. Tar paper covers the roof. An ornately carved six panel door is located in the first floor interior of the house.


