A saddle notched, double pen log barn and an outhouse are also located on the property.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This log house is situated in a hilly, semi-wooded area on Amish Road about 1/8 miles northeast of Durst Road. The house faces north. It is a story-and-a-half, one-bay by one-bay structure with a gable roof. A three-bay by one-bay shed additon is located on the facade. A small wooden porch formed by the extending roof of the additon covers the facade entrance set to the west end.

The house has a central brick chimney. A variety of window types light the house including: 6-pane, 2-pane, 1/1 sash, and 3/1 sash.

The house rests on a high stone foundation (but there is no real cellar). The hewn logs and chinking are exposed on the main block with asphalt shingles in the gable ends and corrugated metal on the roof. The shed additon is covered with asphalt shingles with tar paper on the roof.

Special interior features of this log house include: a built-in cupboard, batten doors, double-bead wainscoting, 9-inch thick walls, and exposed hewn joists. The 10 inch deep northern shed addition is used as a kitchen. The 18' by 24' house is divided into two rooms: a narrow western room and large eastern room. A boxed stair runs along the interior partition.

A saddle notched, double pen log barn and an outhouse are also on the property.

STATEMENT OF SIGNIFICANCE

This log house and barn are good examples of typical Garrett County home-stead architecture from the second half of the nineteenth century. In other areas of the state such "pioneer" structures were uncommon by the late 19th century. In Garrett County however, simple log buildings were constructed through the 1930's. Despite the relative prosperity created locally by coal mining and lumbering in the late 19th and early 20th centuries, farm buildings such as these continued to be a practical form of architecture for independent subsistence farms in mountainous regions.

Other good examples of log farmstead architecture are found within a mile of this farm. Two one-room cabins, The Flossie Bittinger House (G-II-C-232) and the Durst Cabin (G-II-C-269) were probably built slightly earlier than the John Knox House. The Irwin Platter Farmstead (G-II-C-274) includes log outbuildings constructed by 90-year old Irwin Platter about 60 years ago.


