DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Sanders plank-constructed farmhouse is situated in a hilly, semi-wooded area on Dunghill Road. The house faces east. It is a two story, three-bay by one-bay gable roof structure. A single story, two-bay by one-bay shed addition extends across the rear, west, elevation. A wooden porch supported by plain square posts with criss-crossing balustrades is located across the facade.

The house is entered from the center facade entrance or from the north elevation of the addition.

The house has a central brick chimney and an exterior brick chimney at the center of the rear elevation. 1/1 sash windows predominate, with 6/6 sash windows appearing in some places. The house rests on a stone foundation. Asphalt shingles cover the house and the roof.


