DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is situated in a hilly wooded area just north of Ginseng Hill and faces west. It is a two story, three-bay by one-bay structure with a gable roof. A single story addition runs across the rear (east) elevation and includes a small centrally located porch entrance. A wooden porch, supported by four plain square wooden posts, runs across the facade. The entrance in the front is centrally located.

A central brick chimney appears on the house with an exterior cinderblock chimney on the rear addition.

2/2 sash windows light the main structure, with the exception of a picture window directly to each side on the first story north elevation. 1/1 sash windows light the porch addition in the rear.

The house is covered with hexagonal asphalt shingles on the main structure and brick shaped ones on the addition. The roof and the foundation are also covered with asphalt shingles.
