DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame plank construction farmhouse is situated approximately 3/4 miles SE off Swallow Falls Road and a mile northeast of the intersection with Cranesville Road. The house faces northwest. It is a two story, three bay by one bay gable roof structure with a two bay by one bay ell. A partially enclosed single story shed addition is located on the NE elevation of the ell and forms an open porch where it meets the rear of the main block. A plain porch extends across the facade. The house can be entered from the central facade entrance and from the shed porch.

A central brick chimney is located on the ell. Two over two sash windows light the house. Double windows are located on the first story facade and the northeast and southwest elevations. The house is covered with aluminum siding. Asphalt shingles cover the roof.

A frame bank barn lies SE of the house.


