DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Scott Paugh Farm is located on the N side of Paradise Point Road, about a mile E of Sand Flat Road. The farm consists of a brick house, set back from the road, and a barn set next to the road.

The house is a two-story, pyramid-roofed, square-plan dwelling with a two-bay facade. The facade points SE and is covered with a one-story, hipped-roofed, enclosed porch. The NW elevation is also covered with a one-story, hipped-roofed, enclosed porch.

The house rests on a poured concrete foundation and the walls are constructed of brick laid in stretcher bond. The windows are four over one sash and have stone lintels and sills. The facade door is placed in the SW bay. The roof is covered with asphalt shingles and has a single hipped-roofed dormer on the facade.

The house has a single interior brick stove chimney on the NW elevation. The porches are covered with white aluminum siding.

The barn is a frame bank structure, built on a stone foundation, and covered with horizontal siding. The gambrel roof is covered with standing seam metal. The bank entrance points NW and the NE elevation has two brick silos.


