DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Gil Hamill Farm is located on the W side of Turkey Neck Road, about half a mile N of Steiding Church Road. The farm consists of a house and a barn and has a vista to the W of Deep Creek Lake.

The house is a two-story, gable-roofed, square-plan dwelling with a three-bay, center-door facade. The facade points E and is covered with a one-story, hipped-roofed porch. A one-story, shed-roofed storm porch covers the W end of the N elevation.

The house rests on a poured concrete foundation and is covered with German siding. The windows are one over one sash and have drip moldings and plain board surrounds. The house has a three-sided bay on the front elevation.

The roof is covered with tar paper and has two cross gables, one on the N and one on the S elevation. The house has two interior brick stove chimneys, one on the N and one on the S elevation. The interior plan includes four rooms and a central staircase.

W of the house is a frame bank barn. Its bank entrance points NW and the walls are horizontal boards. The barn rests on a concrete block foundation and its gambrel roof is covered with tarpaper.


