DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Holy Cross House is located off Boy Scout Road, on the shore of Deep Creek Lake. The property has a vista of the southern end of the land and Little Snaggy Mountain.

The house is a two-story, gable-roofed dwelling which does not have a formal facade. The main block of the house is positioned with its gable ends facing NW and SE, and gable ells extend from the NW end of the NE elevation and SE end of the SW elevation. The ells are filled with one-story, shed-roofed, enclosed porches.

The house rests on a cut stone foundation and is covered with weatherboarding. The gables are covered with fishscale shingles. The windows are modern 6/6 on the second floor and modern 1/1 sash on the first floor and have plain board surrounds. The entrance door on the NW elevation is flanked by two small rectangular windows. The roof is covered with asphalt shingles and the box cornice returns on all gable ends. The house has one central brick stove chimney.

The interior arrangement of the house is irregular. All walls are covered with vertically placed beaded boards.


