DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Abel Dewitt House is located on the E side of Sand flat Road, about a mile N of Spring Glade Road. The house is screened from the road by trees.

The house is a two-story, gable-roofed, T-plan dwelling with a three-bay, center-door facade. The facade points SW and has a one-story, hipped-roofed porch. The SE side of the T is filled with a one-story, shed-roofed enclosed porch.

The main block of the house rests on a poured concrete block foundation, while the T rests on a concrete-faced stone foundation. All walls except the NW gable end are covered with asbestos shingles. The NW gable end is covered with German siding. The windows are two over two sash with plain board surrounds. The facade door has a single-paned transom.

The roof is covered with asphalt shingles and has a facade cross gable. The house has two interior brick stove chimneys, one just NW of center on the main block and one in the center of the T. The porch roof is covered with asphalt shingles and is supported by square posts and jigsaw brackets. The interior arrangement of the house is unknown.

E of the hosue is a frame, gable-roofed bank barn. The bank entrance points SW.
