**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Homer Bennett House is located on the W side of Sand Flat Road, about a quarter mile N of Spring Glade Road. The house is situated on high ground and is backed by trees.

The frame house is a 2-story, gable-roofed dwelling with a 3-bay center-door facade. The facade points SE and is covered by a one-story, hipped-roofed porch. The NW elevation has two shed-roofed additions and a gable-roofed dormer.

The house rests on a poured concrete foundation and is covered by tar paper. The windows are 6 over 5 and 4 over 4 sash and have plain board surrounds. The roof is covered with tar paper and has a facade cross gable.

The house has two brick stove chimneys, one at the center of the main block and one on the NE gable end. The facade porch roof, covered with tarpaper, is supported by chamfered posts. The interior arrangement of the house was not investigated.
