The Holtschneider Rental House in Deer Park remains relatively unaltered since the prior survey. The dwelling's southeast elevation has been stripped of its single story, frame, full-width porch. The south facing half of the wrap-around porch still remains, although it is presently protected with plastic sheeting tacked on by horizontal wood strips.

The facade is hidden by large evergreen pine and oak trees.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Holtschneider Rental House is located on the north side of King's Run Road, about ½ mile east of US Rt. 219S. The house is set well back from the road and is screened by trees.

The house is a two-story, gable-roofed dwelling with a three-bay, gable-end facade. The facade points southwest and is covered by a one-story, shed-roofed porch. The porch turns the south corner and runs along the southeast elevation. A one-story, shed-roofed addition is attached to the northeast elevation.

The house rests on a stone foundation and is covered by weather-boarding. The windows are two over two sash and have plain board surrounds. The facade door in the westernmost bay of the facade has a single-paned transom. The roof is covered with standing seam metal. The facade's gable peak is marked by a very ornate piece of bargeboard featuring a floral motif.

The house has two interior brick stove chimneys, one in the corner of the main block and one on the addition on the northeast elevation.

The porch roofs are supported by turned posts with plain carved brackets. Over the facade door the porch displays a gabled dormer. The interior arrangement of the house was not investigated.


