STATEMENT OF SIGNIFICANCE

This building is similar in configuration to other schools scattered about Garrett County. A list of trustees first published in 1903 and reprinted in the Glades Star cites Eagle Rock School in District 10. The trustees listed are George Bernard, John Uphold and George Moon. The proximity of this school to Eagle Rock and the George W. Moon Farm (G-IV-B-145) indicates that this may have been that school. The school has been renovated since it was closed.


