The Willoughby Callis House is located south off Smouse Road, about a half mile SE of Loch Lynn. The house is set well back from the road and is surrounded by fields.

The house is a two-story, hipped-roofed, ell-plan dwelling with a three-bay, center-door facade. The facade points north and bears the scar of a one-story porch.

The house rests on a stone foundation and is covered by asphalt roll siding. The windows are sash and have plain board surrounds. The roof is covered with asphalt shingles.

The house has one interior brick stove chimney at the east side of the main block. The interior arrangement of the house is unknown.

Just east of the house is a small balloon-roofed barn.


