DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The William C. Roth Farm is located in an open, hilly area, southeast of Gney Church. The house, a frame two-story, three bay by two bay dwelling with a gable roof, and the frame bank barn are common architectural forms in Garrett County.

The frame, two-story, three bay by two bay house has a central entrance and faces northwest toward a dirt road. There is a one-story, enclosed, concrete-block shed porch across the facade and along the southwest elevation, and a two-story, one bay by one bay shed wing at the rear, southeast elevation.

The main block of the house rests on a stone foundation; the rear wing rests on a wood-form, cast concrete foundation. The walls are covered with german siding; the rear wing has asphalt siding. The roof is covered with standing seam metal.

Windows are 2/2 sash with plain board surrounds and drip-molded heads. There are two interior end brick chimneys and one exterior brick chimney at the west end of the rear, southeast elevation.

The frame bank barn lies southwest of the house. A large brick tile silo sits just west of the barn, and a small chicken house and hog pen lie southeast of the barn.

STATEMENT OF SIGNIFICANCE

The William C. Roth farm house is representative of a common house form found in this section of Maryland, a frame, a-story, 3 bay by 2 bay dwelling.

The Roths were early settlers in the Redhouse vicinity--on the western slope of Backbone Mountain. Their descendants still live on several farms within 2 or 3 miles of the original settlement.
