DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Howard Stahl Farm has an imposing location in an open, slightly hilly area of Pleasant Valley, on the east side of Rt. 219 where it makes a 90° curve to the south.

The 3 bay by 2 bay, 2-story cross-gable frame house rests on a mixed concrete and rubble foundation. The facade faces SW and has a central entrance.

The house is covered with weatherboard siding which has been covered with wood-grained vinyl siding. The weatherboards are still visible under the back porch on the NE elevation. The cross gable roof is covered with tin shingles. Two interior brick chimneys are located at each gable end.

A 1-story frame enclosed porch runs across the facade. The porch is covered with vinyl siding, has a central entrance and 3/1 sash windows. All other windows in the house are 1/1 aluminum sash; surrounds and heads have been removed.

The back porch on the NE elevation is partially enclosed. The open section has turned posts and a jig-sawn, open-worked balustrade with remains of blue and white paint.

A frame bank barn with 2 silos lies SE of the house and a collection of four frame outbuildings and a garage lie NE and SE of the house.

STATEMENT OF SIGNIFICANCE

This house is an example of a common western Maryland type. Houses of this general configuration, a rectangular main block and rear kitchen wing, were constructed in Garrett County from the late nineteenth through the early twentieth centuries.

However, this house features a cross-gable roof and is a prominent house for the southern part of Garrett County.


