DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated among pine trees in a hilly area on G. Swauger Road, approximately $\frac{1}{4}$ mile northwest of Rt. 219. The house faces southwest. It is a two story, three bay by one bay gable roof structure with a single bay deep ell. A wooden porch supported by tapered square posts is located across the facade. A wooden porch supported by turned posts is located along the rear, northeast, elevation of the main block and the northwest elevation of the ell at which point it becomes enclosed. This connects with a single story two bay by two bay addition at the rear elevation of the ell.

The house has a central brick chimney on the main block. Two over two sash windows, framed with plain flat boards, light the house. A double, three over one sash window appears on the first story, southeast elevation of the ell. The house rests on a stone foundation. The house is covered with narrow weatherboard siding with the exception of the rear addition which is covered with aluminum siding. Corrugated metal covers the roof of the house with asphalt shingles on the roof of the porches and rear addition.

A bank barn is also located on the property.




Table Rock: MD;WV
