DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Tasker House, now abandoned, lies $\frac{1}{4}$ mile west of Tasker Corners in a mountainous plateau area which rises from the North Branch of the Potomac River, $2\frac{1}{2}$ miles east.

It is an intact, 2 - story, 4 bay by 2 bay gable roofed frame dwelling with a $1\frac{1}{2}$ story vertical plank kitchen wing located at the south gable end. The kitchen has an exterior shouldered stone chimney at the south gable end.

The house faces east and has a central, double door entrance. The entrances to the kitchen are located at the rear, west elevation, and the south elevation on the west side of the chimney.

The house rests on a low, dry, roughly squared stone foundation. There is no basement. Sills are hewn and lapped at the corners. The walls are covered with weatherboard siding and the roof with standing seam metal. A central brick chimney, set diagonally, is located in the main block.

A 1-story, shed-roofed full facade porch is in deteriorated condition. It has stone footings, a plank floor and chamfered posts.

The windows are 2/2 sash with plain board surrounds with mitred corners. An inset 2-pane casement window is located at the attic story of the north gable end.

The kitchen wing has 6/6 sash windows at the 1st story and 6 pane windows at the $\frac{1}{2}$ story. The asymmetrical kitchen entrance, situated to the north, is offset by 2 windows--one at the 1st story and the other at the $\frac{1}{2}$ story.

The interior of the main block is finished with plain boards. Ceiling joists are exposed and measure approximately 2" x 10".

A frame coal shed is located just south of the house. A frame privy and board and batten granary are located to the north.

STATEMENT OF SIGNIFICANCE

The Tasker House, probably constructed in the mid-late 19th century, is architecturally significant for several reasons. A kitchen wing built to the side of the main block instead of the rear, is an unusual floor plan for this area of western Maryland. Secondly, the vertical plank kitchen still retains its exterior stone chimney. Finally, the integrity of the site is intact. This site deserves further investigation.


