STATEMENT OF SIGNIFICANCE

William Culp, uncle of the present occupant, Mrs Leonard (Irma) Forester, built this house c. 1917. Culp was a mining engineer with Davis Coal and Coke Company at the Henry (WV) Mine. This house is similiar to the Davis Coal and Coke Comapny housing at Kempton (G-V-D-002).

The Dobbin Road, which passes west of the Culp house, runs two miles SE to the Potomac River and south into WV. It is now a jeep trail and virtually impassable; however, at the turn of the century, it led to the lumber town of Dobbin, located north of the road and river. Theonly visible reminder of Dobbin today is a metal truss bridge over the Potomac River (G-V-D-080).
