DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farm house is located at the end of a long lane off Thomas Run Road. The house faces west, away from that road.

The two story dwelling has a one story addition to the north which was built in the 1930's by Alex Shaw. The three bay center section of the house is the original house while the two bay addition on the south is from the mid-nineteenth century.

This house is built onto stuccoed stone foundations. The basement has three-light casement windows. Its roof is gable flank and covered with asphalt shingles. A brick chimney is located at each gable end. These appear to have been replaced. The south chimney, now on the outside, had been on the inside end.

The principal entrance is in the center bay of the five bay house—the third bay of the original house. The moulded panel door has a three light transom overhead. Windows throughout both of the older sections are nine lights over six on the first elevation and six lights over six on the second. Windows have louvered shutters. A three bay, hip roof porch is located over the principal entrance and the flanking windows. The columns have chamfered edges.

Inside, the center section consists of a large room and what was probably once a through hall. A closed stair is located on the south. It has square balusters and a round, pegged newel post. The walls of the room in this section have been paneled. A brick lined fireplace is located on the north wall. Upstairs there are two bedrooms and a small bath. Rooms have beaded plank doors. These are pegged and have small brass knobs and iron latches. In the cellar of this section there is a cooking fireplace. There had also been a dumb waiter which has been closed.

A small, one story frame building, located to the southeast of the main house, had been built as a library. This is two bays by two.

A rubblestone and frame barn is located southwest of the house. It is not owned by the same people that own the house. It has three large arches on the west side. The barn is built into a bank so that the west side is three stories while the east is two.

The center unit of this house is believed to have been standing at the time of the 1798 Tax List. The south addition was added in the latter half of the nineteenth century.

GRG	578	604	Estate of Cassandra Lochary auctioned to the Gaughan family, 1961 113.7 acres, m/l.
JAR	158	495	Fred Lochary executed the will of Mary Calwell, transferring the property to Cassandra Lochary in 1918, 117 acres, 7 perches.
ALJ	31	122	John Lochary family sold the property to Mary Calwell in 1874, 117 acres, 7 perches.
WHD	15	483	Cheyney Hoskins sold to John Lochary the 117 acres, 7 perches in 1865. This land was part of a much larger parcel that had been mortgaged in that same year by Cheyney Hoskins to Enoch Pratt. The land sold to the Lochary family consisted of 50 acres of Leigh of Leighton, Isaac's Inheritance of 40 acres and Second Allotment of 20 acres.
WG	12	119	Cheyney Hoskins acquired Leigh of Leighton (53 acres m/l) and Second Allotment (20 acres m/l) from Rachel and Cassandra Wilson in 1860.
ALJ	9	19	Hoskins purchased the 40 acres m/l of Isaac's Inheritance from Samuel Bond in 1857. (Further traced on other page)
HDG	34	251	Dr. Robert and Stevenson Archer sold 144 acres m/l of Leigh of Leighton, 32 $\frac{1}{4}$ acres of Second Allotment and eleven acres of Third Allotment to Rachel Wilson in 1847.
HD	17	132	Robert Archer sold the beforementioned tracts to Stevenson Archer in 1834.
HD	6	211	In 1822, Robert Archer purchased 49 acres m/l of Leigh of Leighton, from Joseph Slee.
HD	5	506	In 1821, Joseph Slee and Robert Edwards purchased Leigh of Leighton, Second Allotment (30 acres) and Third Allotment. The previous owner was Henry Dorsey of Edward.

- HD R 458 Henry Dorsey of Edward acquired Second and Third Allotments in 1807. He already possessed Isaac's Inheritance and he had purchased Leigh of Leighton in 1803. The property totaled 411 acres, 6 perches with buildings.
- HD 5 506 Henry Dorsey received a patent, presumably from the state of Maryland, for Second and Third Allotments. Isaac's Inheritance (49 acres, 85 perches) was purchased by Dorsey in 1813 from Parker Hall Lee. In 1803, Leigh of Leighton measured 322½ acres.
- HD X 346 Henry Dorsey buys Isaac's Inheritance from Parker Hall Lee.
- HD V 63 In 1809, Parker Hall Lee purchased 200 acres with improvements of Isaac's Inheritance from George Presbury.
- JLG E 4 The only concrete reference to Isaac's Inheritance before 1809 was that in 1785 the Presbury ownership of Ruff's Chance, which is near Isaac's Inheritance, was reported. Apparently, the Presburys owned the tract between 1785 and 1809.
- JLG L 509 In 1794, Robert Morris of Philadelphia sold Leigh of Leighton to Henry Dorsey of Edward. The tract involved had buildings and measured 139 acres, 70 perches.
- JLG F 270 In 1785 Robert Morris either sold or rented the larger part of Leigh of Leighton to James Cain and Philip Quinlan. This is the earliest transaction available for this tract, so it could be assumed that Leigh of Leighton was owned by the Robert Morris family of Philadelphia.

ALJ 5	18	Munnikhysen, John A. to Samuel L. Bond, deed, 1857. This property is listed in ALJ Liber 4, folio 174, 24 March, 1854: 90 acres including portions of Isaac's Inheritance, Uncle's Good Will and also one other lot of woodland in what is called the Big Woods, it being part of a tract called Prospect. 10 acres.
ALJ 5	171	Munnikhysen, John A. from Samuel L. Bond: Mortgage, 1854.
ALJ 9	6	Munnikhysen, John A. from Daniel Scott, Trustee, deed 1857. The above land, sold to Samuel L. Bond is a portion of the land Munnikhysen obtained from Daniel Scott- 240 acres being a part of a tract called Pacas Park from Richard D. Lee (deceased) who received it from his father. Richard Dallam Lee (also referred to as Richard D. Lee) received from his father, Parker Hall Lee:
HD 3	440	Richard D. Lee from Parker Hall Lee, deed, April 27, 1819: Isaac's Inheritance (Or Isaac's Double Purchase) 189 3/4 acres, Prospect 60 1/4 acres. "...together with all and singular the houses buildings advantages heriditaments, and appurtenances whatsoever to the said tracts of land and premises..."
HD 11	437	Richard D. Lee from Parker Hall Lee, deed, June 7, 1828: 2 1/2 acres "part of a tract of land called and known by the name of Pacas Park being that lot of ground which was formerly improved by a certain William S. Dallam and which lies adjoining the town of Abingdon.
JIG P	591	Parker Hall Lee from Mary Lee, deed, January 18, 1802. 500 acres from the tract of land known as Jerico.
JIG M	439	Parker Hall Lee from John W. Donald, deed, October 31, 1795: part of a tract of land known as Prospect "Beginning at a stone set up in the great road leading from Lower Crofs Roads to the Hiccory..." Consisted of 107 acres.
JIG L	475	Parker Hall Lee from Edward Flanagin, deed, August 4, 1795: Consisting of 91 acres from the tract known as Prospect.


