This stone dwelling is thought to have been the tannery described by George Cook in Samuel Mason Jr.'s Historical Sketches of Harford County, Maryland. Mason wrote that "In 1842, Elisha (Cook) built a small, stone house near the public road where he settled his son, George P. Cook, as a storekeeper and who kept store on the ground floor for forty years. During this time, not being thoroughly content to wait for trade, George built a tanbark mill across the brook near the road and a dwelling for the operator opposite to it."

This area, being heavily wooded, was perfect for a bark mill and tannery and it prospered for many years. Lloyd Weaver, a former owner and stone mason and artist of local reknown, filled in the tanning pits that held the soaking hides in 1937. He also renovated the structure for use as a family dwelling.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two story stone dwelling is located on the northern side of Harmony Church Road in the village of Cooksville. The house faces south. A block addition is located at the east end.

The structure is four bays by two. The gable flank roof is covered with slate. A corbeled brick chimney is located at each gable end, flush with the wall. There are large stone quoins and stone lintels.

The principle entrance, located on the south facade is in the second bay and is flanked by a now closed, stone archway, on the west and a 6/6 window on the east. The eastern-most bay is blank on the first elevation of this facade. The stone archway on the west is thought to have served as an entrance for water used in the tanning operation alleged to have been performed in this structure.

Three windows and a door are located on the south facade's second elevation. The windows are 6/6 and the door, on the eastern-most bay, opens onto a small, wooden landing. The door, itself, is board and batten.

Fieldstone - stone house, formerly a mill for making leather - a tannery. Two stories, four bays long and one room deep, it faces south, the ridgeline running east-west. The east section is a cinder-block addition. Two chimneys rise from heating fire places. There is an upstairs door in the right side (east) of the main building.

A three foot high five foot wide brick arch, ~~at~~ to the left (west) of the central door, where the mill race brought dilute water into the mill.




