The rural crossroads service is an important factor in American town planning. Where major thoroughfares met one was likely to find a store which sold nearly everything and was a post-office as well, one or more craftsman such as a harness maker or cabinet maker and perhaps even a doctor or lawyer's office. One would also expect to find a blacksmith and wheelwright.

Such was/is the case with Hopewell Crossroads (now called Level) and the blacksmithy run by William Foard and his father has been an integral part of this village for a hundred years.

It was my privilege on August 6, 1980 to spend some time with the son of Edison H. Foard, William Foard. Mr. Foard is 95 years old, having been born 1885. He is of healthy body and mind and a bit of a "ham". He is one of the most important historical resources I have encountered.

It is not the first time that I have met him as I was introduced to him by Natalie at the beginning of the summer.

It has taken that long to get to Level and to investigate this N.R. district. (multiple resource). Very old log houses, frame houses, stores and the almost famous Foards Blacksmith Shop are the visual documents of 19th C. "X Roads" life in Harford County. More than these are the people who still live in these buildings, equally valuable historical resources with even less chances of survival than constructions of wood, clay or rock.

Although the shop no longer produces wrought metal necessities it is nevertheless "open" and this venerable information of that which is gone is present each day to greet those who would enter. The forges are cold, they have been for years, there is even pre-auto left-over stock, but he is there. Mr. Foard is aware of his importance both as a retired social necessity and a link with the past.....

Whatever can be said of the value of Mr. Foard as a human link with history can also be said of Mrs. Annie Stearn (HA-921). We learned much about the woman on August 6, 1980; not as much as we could have or wanted to.

Mrs. Stearn is 84 years old and has spent all of that time within a couple of miles of Level. She has lived in her loghouse on the X-Roads since 1937. Hers has not been an easy life; it is whatever its quality (considered personally to be high) part of the history of this building.

Mrs. Stearn lives in a log house where she raised 10 children alone during the great United States Depression of the 1930s.

1935 was a particularly bad year for this Harford County farm-girl. While pregnant with her 10th child she lost both her eldest son and husband in the same year. She "kept store" at a location in E. Level (HA-919) for two years and then quit to devote all of her time to keeping her family together. She sewed the clothes for ten, she grew a garden as she does now, canned for winter time and accepted the generosity of her family and neighbors. Her father and brother cut the wood she needed for the stove. As the children grew they did not leave. Nine of her ten children still live within 2 miles of their mother. Mrs. Stearn said that while they were home there was never any thought of having money 'of your own'. Whenever they acquired any the family members always gave their money to Mrs. Stearn to use in the family's interest.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Although the house and site played an earlier role in the history of the rural crossroads service center of Hopewell Crossroads the real significance of the site is the old blacksmithy which Edson Foard erected c. 1882.

The stores, wheelwright and blacksmith shop, saddle maker, carpenter and coffin maker, doctor etc. were an important collection of services in a rural community which knew literally miles of open space. It is an "egg-and-chicken" argument as to whether the crossroads drew such services or the collection of such needed matters came first, but it is an unarguable fact that they existed and Hopewell Crossroads was one of them.

Chief among the necessities in an early automated society was the blacksmith. Edson Foard and his son William were the blacksmiths for this area. We are fortunate that William has lived 95 years and has maintained his health. He has been interviewed, taped and photographed repeatedly for years. He has not lost his enthusiasm for explaining his lost art or desire to communicate with those maturing in a time much different from his own.

### Building Description

The old house, smithy and its additions form a rather large complex. The original shop, however, is only 24' wide and 40' long. A 24' X 30' work area has a storage in its north end. The shop is right in the north side of the old road to Havre de Grace approximately 100 yards east of the crossroad. It is designed for its process.

This is a frame building, gable ended with a longitudinal plan covered with but joined vertical weather board. It is and always has been painted barn red.

Longitudinal in plan the smithy has large 8' wide double doors opening to the road. Inside are two forges, an open work area, and an endless collection of materials and tools, many of which have been custom made in the site.

This is a frame building built of circular sawn materials, but having the ancient method of post-beam and brace construction. It is well lighted by at least a dozen and a half openings. It is assumed that these windows and doors were for both ventilation and light as this work is both intricate and hot. Mr. Foard recalls that in its prime as many as "several smiths" might be working about the forges with "others on the floor" and in summer "you'd be wet in the seat of your pants". This is a space in which heat and human strength have been brought to bear on steel and iron in order to keep a community plowing, harvesting, hauling, etc. for almost a century.

The forges themselves are stone construction approximately 4-1/2' X 4' and waist high. They are hollowed out to burn coal and are served by brick flues. Three feet in front of each forge also at waist level, is an anvil.



Frame building, board and batten, facing south through two wide doors, the ridge line north-south. Well lighted, the doors have windows, and windows are beside them, the west wall having 4 windows  $\frac{6}{6}$  and a door. One sack of 6 pines under the peak.

The stone floor supports 4 several anvils and the forge, still running. The rafters are hung with supports of iron bars and straps.

Five blacksmiths worked here simultaneously in the busy summer season when Mr Foard was a young man. Two would shoe horses all day, the others make tools, mend wagons and replace metal tires on the wheels, etc.

Now 82 years old, Mr Foard gave up shoeing horses about 10 years ago, but still runs the forge, mostly to repair antiques.




