The Walter Tenant House is a fair example of late 19th century vernacular architecture in Harford County. The pendants at the corners of the eaves are somewhat unusual surviving decorative elements. They were a common feature in late 19th century pattern books, but often deteriorated or were removed during 20th century alterations.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Walter Tenant House is a two story frame house with a central gable and a shed porch, built about 1880 on the west side of Ady Road (Maryland Route 543) about 200 yards north of Deer Creek near Ady, Harford County, Maryland. The main elevation faces east.

The east facade has three bays with the entrance in the center. The center gable has a small round-arched window. Most other windows are 2/2 and are flanked by louvered shutters. The entrance has a rectangular transom and sidelights. The porch has square posts and simple curved brackets. The gable ends of the main section have two bays and interior brick chimneys.

A two-story wing extends from the southwest corner of the main section. A third chimney projects from the west end of the wing.

The foundation is stone and the exterior is green aluminum siding. The slate roof has small ball pendants at the eave corners.


