Stone stuccoed farmhouse, ^{double} gabled, two stories, three bays by three in the main section facing west, the long wing runs east along the south wall, three bays by two, with a third section two bays by two behind that. Prognosis of the first and third sections run north-south, the middle section east-west. There are three brick chimneys at gable ends of the first and second sections.

Inside, partitions have been removed to make a front parlor whose ceiling is supported by 1 beams.
