DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This rustic, two-story structure has been extensively altered but it still possesses the original proportions. The mill faces towards Deer Creek to the east. The walls are chinked and pegged logs, but the gables are covered with wood shingles. A new shed addition is located on the western side of the building. The stone foundation is high and entirely exposed on the eastern side. The mill measures two bays by three, with 6 X 6 windows in nailed sashes. An exception is a twelve-pane window just to the left of the cellar door, situated on the eastern side. A first-floor door is located on the northern exposure, while a second is stationed on the northern end of the shed addition. The cellar opening still has a board-and-batten door with original hinges. An asphalt-covered gable-flank roof tops the mill, and a single stone chimney is positioned on the inside-end along the western slope of the roof. AN L-shaped porch wraps around the north and the east facades, being of six bays and resting on stone pillars.

STATEMENT OF SIGNIFICANCE

The present mill is located on a tract that was patented originally by the McKemson Brothers in 1771, a 115-acre tract called "Black Rock". The first mill was built on this site between 1771 and 1781. At that latter date, Matthew Wiley, Sr., the son of David Wiley, acquired this property. This Wiley family had operated mills in Chester County, Pennsylvania. Matthew Wiley constructed this mill in the early 1800's, giving him a total of three mills along the tributaries of Deer Creek (Ivory and Amos Mills). The property was passed to the elder Matthew to his son, Matthew, in 1840, and from Matthew, Jr., to George N. Wiley in 1878. The mill was used for lumbering and cider-making as well as for flour production.
