DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This structure faces the south and is in two parts; the eastern one being a one and one-half story coursed stone building with quoined corners, and the second being a two-story bevelled frame structure. The stone structure is three bays by two, while the frame one is two bays by one. There are two small attic windows on either end. (The western ones have been covered over). The stone house has 2 X 2 sashes in narrow, pegged frames and the dormers and the frame section have 6 X 6 windows. A cellar opening is located on either side of the doorway on both sides of the masonry walls. A low stone foundation is found underneath the frame section. There are two sets of opposite doors on both wings, oriented north-south, with the stone house's being inset. Gabled dormers are located on the roof of the main section, two on the south side and one on the north side. The asphalt roof is gable-flank overall, with a new box cornice below it. The brick chimneys are original; two are inside-ends sited on the eastern and western extremes of the main house, and a third outside-end is positioned on the western end of the frame wing. It has a stone base and a brick upper flue. The porches are all of later vintage and they all have shed roofs. A two-bay is over the south door of the frame section, a shelter covers the opposite entrance and a one-bay protects the stone house's southern doorway.

STATEMENT OF SIGNIFICANCE

The house sits on a tract that was said to be a part of the tract called "Friendship". Samuel and Nathaniel Hughes owned most of this tract until the 1770's when the property was sold to Samuel Thomas. Other owners of the tract and it's parts, according to the 1783 Tax List, were Jacob Giles (200 acres) and Thomas Hall (160 acres). The house is quite old, probably as old as 200 years, but gaps in the land records make it impossible to determine it's actual age. The 1798 Federal Tax List does indicate two possible sites and owners of the place for that time:

Johanna Giles 102 acres ^{*} 33 X 36 frame house, 30 X 30 stone kitchen, 12 X 12 milk house, 20 X 18 brick counting house, 14 X 12 cornhouse.

John Hall Hughes 287 acres, ^{*} 30 X 25 stone house, mentions the widow Touchstone as being a tenant.

The earliest land record mentions a land suit involving the Hughes and the Touchstones, so that would make the second entry the most likely candidate. During the second two-thirds of the Nineteenth Century, the Botts family owned the property.

Architecturally, the house has retained most of it's original features and design, and due to the age of the structure and the purpose it served, the existence of so many original aspects is noteworthy.

GRG	455	23	In 1956, Winfield Botts, widower, sold 50 acres to Aubrey, Lawrence and Joseph Worthington.
GCB	288	85	In 1945, Michael W. Fahey, trustee, sold the 50 acres to Winfield Botts.
JAR	142	475	In 1914, Lester G. Botts bought 50 acres from Archer M. Botts and others. Lester died and the land was resold by the trustees.
ALJ	25	235	In 1870, the property was conveyed to W. Goldsmith Botts by George W. Botts. The tract was a 95 acre portion of Friendship, left to George by John Botts.
HD	27	218	Richard Mitchell sold the 95 acre portion of Friendship to John Botts in 1835.
HD	15	23	In 1831, Richard Mitchell received the 95 acres from John Kean, trustee. The land was put into Kean's hands following a court case involving Richard Mitchell v.s. Nathan Touchstone, John Touchstone and James Hughes. The records are incomplete previous to this date, but the land could have possibly been in the Mitchell family.


