### DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a "T"-shaped home that faces to the southeast. The cross of the "T" is the main portion of the home and dates from the last quarter of the Nineteenth Century, while the wing is of much earlier origins, although it does have a shed addition on its southwestern side. The entire structure is two-storied, with bevelled-frame walls and a low stone foundation. The main section measures five bays by one, while the kitchen wing is three by one. The windows are not new, nor are they original, being 6 X 6's in the kitchen and 2 X 2's in the rest of the house. Black shutters flank most of the windows. A single 2 X 2 window is on the attic level of the northern end of the kitchen. Arched Victorian 2 X 2 openings are on either gable end and under the quasi-dormer on the center of the face of the main section. These areas are also decorated with shingle trim of the imbricated type. The southern entrance is quite elaborate, with three-pane transoms and side lights. Two more doors are stationed on the west side of the kitchen on the shed addition, and a fourth entrance is located on the eastern side of the kitchen. The new roof is gable flank, with asphalt shingles, and underneath are new eaves and soffits. One three-bay shed porch shelters the eastern entrance to the kitchen, while the main southern entrance has a more elaborate enclosure, with brackets on the columns and dentiling along the sides of the shed-roof. A pair of brick chimneys straddle the ridgeline of the interior of the main part of the house, while another brick flue is on the northern inside-end of the kitchen. The few cellar windows and the cellar way are located on the western side of the house.

STATEMENT OF SIGNIFICANCE

This house is located on parts of two old tracts called "Eightrupp" and "Eaton". Reuben Perkins, whose family had run the ferry since the very early 1700's, sold part of the present tract to John Hughes in 1774, which included Miller's Tavern. The other portion was one owned by Henry Stump, who had acquired most of his parcel from Perkins in 1772. The 1783 Tax List shows Henry Stump as owning 50 acres of "Eightrupp". After the turn of The Nineteenth Century, the land was bought by Isaac Willey, a local barge captain, and in the 1830's, the land returned to the Hughes family. They probably built the Victorian section of the house, as their ancestor John had constructed the kitchen. The 1878 Martenet map indicates an Evan T. Hughes as living there. The larger part of the house dates from this time, while the kitchen is much older, possibly pre-1800.




