Frame house with asphalt shingle covering on stone basement, unlighted. L shaped, 3 bays x 2 with a 2 x 2 wing running west along the north wall, the 2 1/2 story house faces east, the roof ridge line running north-south.

A large dormer faces east <sup>with</sup> a window similar to that in the end wall with a rounded top, 2 lights over 2. Other windows are 6 lights over 6.
