DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The frame house, 2 stories, faces east 4 bays x 1, with a small 1 story wing running west along the south wall under a lean-to roof. ~~Grouping of windows indicates that an addition to the house at the south end~~ The roof ridge line runs north-south, slate over wide eaves, a shallow-pitch roof.

Grouping of windows and chimneys indicates that an addition to the south end was made to a 3 bay house with a ~~chimney~~ chimney at either end.

A one-story porch shelters the north part of the house.

Since the roof is continuous and, being slate, cannot be older than 1860, it seems logical to date the addition at or after that date.
