

This stone masonry smoke house is almost square, a low pitched roof of cedar shingles has a ridgepole running north-south. A door in the long side facing east is unlighted, a single small window is centered in each other side, bricked in with vents to release the smoke but supply some oxygen to the fire slowly. No chimney. A datestone in the south gable reads B.A. 1857 - Benjamin Almon owned the farm at that time.
