Once a small barn, this frame house in two parts is covered with "brick-patterned" tarpaper and with aluminum siding. Oblong, 3 bays x 2 downstairs in the main part, there are 2 small hinged sashes near the floor upstairs; the other section has a door and a window downstairs and one similar upstairs hinged sash.

Facing ~~west~~, very near the road. The A roof ridge line runs north-south. One small chimney rises from stoves along the inside wall.
