DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Frame farmhouse, asphalt shingles in yellow brick pattern covering clapboard. L shaped. The main house faces west towards Paradise Road, the wing runs east along the north wall. A one story porch shelters the first floor of the main house and a one-story porch on the south side of the wing is enclosed. The peaked roof/ridge line runs north-south, and the eaves are decorated in a wide scalloped board.

3 bays by 2, the wing is 2 bays x 1 with ceilings and eaves the same height as the main house. Windows have 2 lights over 2.

The wing has an inside flush chimney containing 2 flues in the east end wall.
