STATEMENT OF SIGNIFICANCE

The three houses on Holloway's Lane appear to be the same three houses that are now listed as 7, 103 and 109 and also shown on map of 1799. The history of the three houses has not been fully recorded. Before his death, Harry B. James said that these three houses were the oldest in Aberdeen. His statement could be correct for at that time, Aberdeen had not extended its boundaries from the original survey made in 1897. These three homes, like others mentioned, have changed their appearances over the years. (Page 9, "History of Aberdeen"; Richard F. Cronin, 1976)

103 Holloway Lane is a 2-story I-frame with extension, 2 bays wide and 1 bay deep on stone with gable roof and central chimney. South extension is 2-story, 2 bays wide and end chimney.

This house, according to Richard Cronin is now the only one of the few houses known in 1931 to have been in Aberdeen at the end of the 18th Century. Aberdeen was then known as ~~three~~ ^{three} villages, Halls Cross Roads at Post Road and Bel Air Ave., ~~with its own justice office,~~ Aberdeen at or east of the Pennsylvania Railroad, and Mechanicsville, near Paradise Road. (This house ~~is~~ ^{appears to be} noted on the Martone's Map of Harford County of 1878 as Hall's Park.)
