Frame school house, clapboard covered, with two rooms, built in two stages. Oblong, the roof/ridge line runs north-south with the entrance on the east side. A small bell-cupola is near the center of the A-roof/ridge line. One story high windows are on the east and west side walls only. At the south end of the building windows have 4 lights over 4, at the north larger sashes have 6 lights over 6.
