This 2-story, frame house was built in 2 sections: the 3 bay section on the West is older and may be log. Located right at the crossroads of Level, Annie Stearn's house along with Foard's Blacksmith shop is a landmark of the 19th century Village known as Hopewell's Cross Roads. The shed northeast of the house was a cabinetmaker's and later a harness shop. At that time this intersection of the roads to Havre de Grace and Rock Run was a busy trading center, and although there is little commercial activity now, the village has remained relatively undisturbed.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Annie M. Stearn House

This 2-story, 2-part frame clapboard-and perhaps part log-house is located on the south side of Rock Run Road, just east of the intersection with Old Level Road in Level.

The present front facade faces north, although the south facade may have been the main one at one time, and the gable roof ridge line runs east-west. The oldest section, 3 bays wide and 1 room deep, measuring 16'2" by 24'3" with a brick chimney in the west end, is on the east; it is said to be log and the width of the walls suggest that indeed it may be. The later (and lower) 2 bay by 1 bay section is 15'10" X 16'2" on the west, with the north and south sides of both sections flush. The cornice of both sections is raked with exposed eaves, and there are wooden shingles in the west gable of the east section. Most windows have 6/6 sash, with 3/6 sash in the 2nd story of the east section and 6-light knee windows in the 2nd story of the west section. The south facade has wide plain window trim, the north facade has narrow beaded trim. A one-story shed-roofed porch with turned posts spans the south facade, where there are 3 entrances: in the westernmost bay of the west section and in the center and east bays of the east section. The entrance in the center bay of the north facade is sheltered by a one-bay, shed-roofed portico. A bulkhead in the east end provides access to the basement, which has full log joists and sill.

The interior contains 2 rooms in the east section, with a winder staircase in the south-west corner and one room in the west section. There is a chimney and stove flue in the west wall of the east section.

Northeast of the house is a frame shed, once a cabinetmaker's, then a harness shop. Measuring 16'6" by 26'6", the 2-story gable-roofed shed has a 1-story 8' by 16'8" shed-roofed lean-to on the south side. The shed has a hewn post and beam pegged frame and tree rafters pegged together. Originally open to the roof, a second floor and staircase were recently installed. Several curious features that should be noted are: the row of closely-spaced square and round pegs in one of the joists, the intermittent, but regular-sized holes in the vertical board exterior sheathing; and the pintel hinges and wrought latch on the west entrance, probably made in Foad's blacksmith shop across the road.

STATEMENT OF SIGNIFICANCE Annie Stearn House

The eastern section, perhaps log, of this 2 part house may date from before 1858, although historical research is indefinite. The 1858 Jennings and Herrick Map indicates 2 structures near this location - one belonging to Gallion, the other to Mitchell. The 1878 Martinet's Map, crowded with names around the cross roads, may indicate the presence of J. Bowman here. The title search cannot trace the land before 1888 when James Bowman was involved in an equity dispute involving Henry Bowman's estate,¹ (will dated 1871) and is indicated as buying and selling a number of lots around Level.

The advertisement in the Harford Democrat on July 9, 1859, for William S. Bowman's Cabinet Making and Undertaking Enterprise, which was probably housed in the shed, informs "his friends and the public generally that he is now prepared for manufacturing all articles in the above line at Hopewell Cross Roads, Harford County, and would respectfully solicit the patronage of the community. He will manufacture to order bureaus, Beadsteads (sic), wash stands, work stands, tables, cradles and c . . . particularly attended to, coffins of all kinds, furnished to good order, walnut, mahogany, cherry, poplar, and c . . . "

In 1889, the lot was sold to Rachel L. Rogers², and from 1903 until 1914 it belonged to Jon. Sheridan and his heirs. The house was purchased in 1916 by Luther and Annie Stearn and is still the residence of Annie Stearn.³

Along with Foard's Blacksmith Shop and Bradfield's store, the Annie Stearn house is a Landmark of turn of the century Level. The crossroads (known as Hopewell X Roads) at Level where the road to Havre de Grace and to Rock Run intersect was a busy commercial center in the second half of the 19th century. Although there is little commercial activity there now, Level has retained a strong identity as a Village and remains much as it was at the beginning of the twentieth century.

This small house in two parts is log and frame construction covered with clapboard. Overall the larger section is frame, 2 stories, 3 bays by 2; the smaller part 1½ stories, 1 bay by 1, of log. Facing south, the A roof ridge lines run east-west. A chimney rises from a location just east of the smaller section and rises from the S.W. exterior of this log part, now enclosed in the frame section. Windows on the first floor have 6 lights over 6, upstairs 3 over 6.


